WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Furniture and Fixtures (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 2,282,400.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 8, 2023;

WHEREAS, in response to the Invitation to Bid, seven (7) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on September 15, 2023;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on September 27, 2023, at 2:00 P.M.:

- (a) Four bidders, namely, Vedula Enterprises Inc., Peniton Trading, Real Form Furniture Shop, and Tarlac Mac Enterprises Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Vedula Enterprises Inc., Peniton Trading, Real Form Furniture Shop, and Tarlac Mac Enterprises Inc., to contain all the required documents and were rated "passed".
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the four bidders whose first envelopes were rated "passed",
- (d) the BAC resolved to declare Tarlac Mac Enterprises Inc., as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 1,889,600.00, and
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) on October 27, 2023:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,

- (b) the TWG for Technical Aspect reported that the LCB was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Tarlac Mac Enterprises Inc., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 1,889,600.00 and,
- (b) to recommend to the President the Award of Contract for the project Supply and Delivery of Furniture and Fixtures (APP 2023) to Tarlac Mac Enterprises Inc.

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Furniture and Fixtures (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 2,282,400.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 8, 2023;

WHEREAS, in response to the Invitation to Bid, seven (7) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on September 15, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on September 27, 2023, at 2:00 P.M., four (4) bidders, namely, Vedula Enterprises Inc., Peniton Trading, Real Form Furniture Shop, and Tarlac Mac Enterprises participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the four bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Vedula Enterprises Inc., Peniton Trading, Real Form Furniture Shop, and Tarlac Mac Enterprises contained all the required documents and were rated "passed";

WHEREAS, the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the four bidders and found that the envelopes of the four bidders contained the prescribed documents and were rated "passed";








WHEREAS, the BAC with the assistance of the TWGs, proceeded with the evaluation of the financial bids of the four bidders with the results as summarized below:
