WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Increase in Carrying Capacity of Nursing and Allied Health Programs with an Approved Budget for the Contract (ABC) of ₱ 50,000,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 18, 2023;

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) on September 26, 2023;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) on October 10, 2023, at 2:00 P.M.:

- (a) Three bidders, namely, Scigate Technology Corp., Aspen Multi-System Corp. and Kaitliana Trading Corp., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the two bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of Scigate Technology Corp., Aspen Multi-System Corp., and Kaitliana Trading Corp., to contain all the required documents and were rated "passed".
- (c) the BAC with the assistance of the TWGs, proceeded with the opening and evaluation of the second envelopes of the three (3) bidders, found that their envelopes contained the prescribed documents and were rated "passed",
- (d) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the three bidders,
- (e) the BAC resolved to declare Aspen Multi-System Corp., as the bidder with the Lowest Calculated Bid (LCB) for Lot No. 1 with the bid price of ₱ 33,880,000.00, and
- (f) to declare Kaitliana Trading Corp., as the bidder with the Single Calculated Bid (SCB) for Lot No. 2 with the bid price of ₱ 4,304,500.00,
- (g) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

- (b) the TWG for Technical Aspect reported that the LCB for Lot No. 1 was non-responsive while SCB for Lot 2 was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB for Lot 1 as non-responsive and SCB for Lot No. 2 as responsive;
- (d) the BAC directed the Secretariat to issue the Notice of Disqualification to Aspen Multi-System Corp.
- (e) the BAC directed the TWGs to evaluate the 2nd Lowest Calculated Bid for Lot No. 1;


THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

WHEREAS, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on September 26, 2023;

WHEREAS, in the public bidding held at the TSU-BC AVR on October 10, 2023, at 2:00 P.M., three (3) bidders, namely, Scigate Technology Corp., Aspen Multi-System Corp., and Kaitliana Trading Corp., participated and tendered their bids for the aforementioned project;

WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the three bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of Scigate Technology Corp., Aspen Multi-System Corp., and Kaitliana Trading Corp., contained all the required documents and were rated "passed";
