APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 1,400,000.00

WHEREAS, Tarlac State University, through the Bids and Awards Committee (BAC), and in accordance with Section 53 of the IRR, and following the procedures prescribed in Annex H of the IRR for Two Failed Biddings, advertised the Invitation to the Negotiated Procurement for the Supply, Delivery, and Fabrication of Drafting Tables for the College of Architecture and Fine Arts with an Approved Budget for the Contract (ABC) of ₱ 1,400,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS), the TSU website, and in conspicuous places in Tarlac State University on February 14, 2024;

WHEREAS, in response to the Invitation to the Negotiated Procurement, two (2) prospective suppliers participated in the negotiations held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via zoom on February 22, 2024;

WHEREAS, after the completion of the negotiations with the prospective suppliers, the BAC, through the Secretariat, requested all prospective suppliers who attended the negotiations to submit their best quotations, based on the final technical and financial requirements for the project, on or before March 5, 2024 (2:00 P.M.);

WHEREAS, on the specified deadline for the submission of quotations:

- (a) one supplier, namely, Progress Home and Office Furnishings, tendered a quotation for the aforementioned project,
- (b) the BAC, with the assistance of the Technical Working Groups (TWGs), opened and evaluated the quotation of the lone supplier and found it to be substantially complying to the prescribed eligibility, technical, and financial requirements for the project and was rated "passed",
- (c) the BAC resolved to declare Progress Home and Office Furnishings, as the supplier with the Single Calculated Quotation (SCQ) with the price quotation of ₱ 1,389,000.00, and
- (d) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the SCQ;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on March 26, 2024:


- (a) the TWG for Financial and Legal Aspects reported that the SCQ was responsive to the prescribed legal and financial requirements for the project,
- (b) the TWG for Technical Aspect reported that the SCQ was responsive to the prescribed technical requirements for the project, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the SCQ as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Progress Home and Office Furnishings, as the supplier with the Single Calculated and Responsive Quotation (SCRQ), with the price quotation of One Million Three Hundred Eighty-Nine Thousand Pesos (₱ 1,389,000.00) and
- (b) to recommend to the President the Award of the Contract for the project Supply, Delivery, and Fabrication of Drafting Tables for the College of Architecture and Fine Arts to Progress Home and Office Furnishings.



WHEREAS, due to the two consecutive failed public biddings for the project Supply, Delivery, and Fabrication of Drafting Tables for the College of Architecture and Fine Arts, the Bids and Awards Committee (BAC) recommended to the Head of the Procuring Entity the procurement of the project through negotiated procurement, as prescribed in Section 35.5 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184;

WHEREAS, Tarlac State University, through the BAC, in accordance with Section 53 of the IRR, and following the procedures prescribed in Annex H of the IRR for Two Failed Biddings, advertised the Invitation to the Negotiated Procurement for the project Supply, Delivery, and Fabrication of Drafting Tables for the College of Architecture and Fine Arts with an Approved Budget for the Contract (ABC) of ₱ 1,400,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS), the TSU website, and in conspicuous places in Tarlac State University on February 14, 2024;

WHEREAS, in response to the Invitation to the Negotiated Procurement, two (2) prospective supplier participated in the Pre-Negotiation held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via zoom on February 22, 2024;

WHEREAS, after the completion of the negotiations with the prospective supplier, the BAC, through the Secretariat, requested the prospective supplier who attended the negotiations to submit his/her best quotation, based on the final technical and financial requirements for the project, on or before March 5, 2024 (2:00 P.M.);

WHEREAS, on the specified deadline for the submission of quotations, the BAC received and accepted one (1) quotation from the supplier Progress Home and Office Furnishings;

WHEREAS, upon receipt and acceptance of the single quotation, the BAC, with the assistance of the Technical Working Groups (TWGs), opened and checked the quotation, using the non-discretionary “pass/fail” criterion, and found that the quotation contained all the required eligibility, technical, and financial documents;


WHEREAS, the BAC with the assistance of the TWGs, then evaluated the financial quotation of the lone supplier with the result as summarized below:

THEREFORE, based on the foregoing findings, WE, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (a) to declare Progress Home and Office Furnishings as the supplier with the Single Calculated Quotation (SCQ) for the project Supply, Delivery, and Fabrication of Drafting Tables for the College of Architecture and Fine Arts with the aggregate amount of ₱ 1,389,000.00 and;
- (b) to direct the Technical Working Groups to proceed with the Post-Qualification Evaluation of the SCQ and report their findings to the BAC within the prescribed period.


